### Pay-by-License-Plate

Starting December 26, 2016, the multi-space parking kiosks will switch to "Pay-by-License-Plate." Changes will be implemented during holiday free parking week (December 19-24.) The change consists of entering the license plate number using the alpha-numerical keypad when paying instead of the space number. All other aspects of the kiosks remain the same. Payment is still accepted by coins, bills, credit card, and pay-by-phone with the ParkLancaster or Parkmobile App.

Switching to the license plate will allow for a more consistent and accurate method of payment and enforcement throughout the city. To aide in remembering your license plate, we suggest either taking a picture of your license plate, saving your license plate number in the ParkLancaster App, or using a complimentary LPA key tag filled out with your license plate number. Key tags are available for free at the LPA office and at multi-space kiosks throughout Lancaster City.

### Parking Changes FAQ's

#### When are on-street meters enforced?

Per city ordinance, enforcement times will remain the same:  
Monday - Saturday 8 a.m. to 6 p.m.

#### Will the rates for meter parking change?

No, the rates for meter parking will not change at this time. Meters remain at \$.25 cents for 10 minutes. Meters have a two hour time limit.

#### Will garage parking change?

No, garage parking will not be affected by pay-by-plate or changes to enforcement at this time.

#### Will enforcement only take place downtown?

No, enforcement will be implemented city wide. Not just in the downtown investment district.
