

ENFORCEMENT



Central Business District

Parking enforcement officers (PEOs) patrol the Central Business District several times during the day.

PEOs use a handheld device that tells them if the vehicle has paid time left or not.

Street Cleaning

Street cleaning is conducted every two weeks on residential city streets and weekly on some major corridors.

By law, vehicles must be moved. LPA parking enforcement officers follow the street sweeper and ticket any vehicles in the way of the street sweeper.

Residential Permit Parking

Residential Permit Parking (RPP) can be daytime, nighttime or both. More than 136 blocks of residents choose to take part in RPP by their homes.

There is a two-hour grace period for daytime parking on RPP blocks.

Loading Zones

These zones, marked by signs, are located throughout the city to reserve spaces for delivery vehicles in the area. There is regular enforcement of loading zones. Most loading zones allow for a stop of up to 20 minutes.

The Lancaster Parking Authority (LPA) manages all aspects of parking for the City of Lancaster. LPA operates garages, surface lots, and metered parking spaces. It provides enforcement for on-street parking, the Residential Parking Permit (RPP) program, street sweeping and other traffic violations.

Mon-Fri: 8 am to 6 pm in other areas

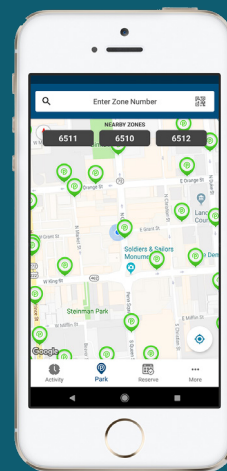
