## **Rate Resolution**

WHEREAS, the Parking Authority of the City of Lancaster (the "Authority") is the owner of parking garages, surface parking lots, parking meters and other parking facilities (collectively the "Parking Facilities") throughout the City of Lancaster which are operated by the City of Lancaster (the "City") and managed by the Authority; and

WHEREAS, pursuant to the Authority's trust indentures dated September 15, 2007, February 11, 2016, December 15, 2016, October 1, 2019 and December 1, 2020 which require a resolution for fixing and charging parking rentals, rates and other charges upon Persons that use the Parking Facilities; and

WHEREAS, the Authority wishes to place into effect a Rate Resolution imposing parking rates for the use of the Authority's Parking Facilities in compliance with the Rate Covenants set forth in the indentures.

NOW, THEREFORE, BE IT RESOLVED by the Board of the Parking Authority of the City of Lancaster as follows:

- 1. The parking rates, set forth on Exhibit A attached hereto, made a part hereof and incorporated by reference herein, are hereby approved.
- 2. The parking rates set forth herein are hereby imposed on users of the Parking Facilities and such rates shall become effective, retroactively, on January 1, 2021.
- 3. All resolutions and parts thereof, insofar as they are inconsistent with this Resolution, are hereby repealed or rescinded.
