Minutes for the Regularly Scheduled Board Meeting held

### August 22, 2024

The Lancaster Parking Authority (LPA) held its regularly scheduled board meeting on Thursday, August 22, 2024, at 8:06 AM at the LPA Administrative Offices at 30 W. Orange Street, Lancaster, PA.

#### Approval of the Minutes

The meeting was called to order by Mr. Sollenberger at 8:06am. Mr. Sollenberger noted that a quorum for the meeting was met with two Board members present, Mr. Weaver and Mr. Sollenberger, and one Board member, Ms. Ryan, participating by phone. Minutes from the July 25, 2024 Board meeting were reviewed by the Board. A motion was made by Mr. Weaver and seconded by Ms. Ryan to approve the July 25, 2024 minutes. All Board members present approved the motion.

## Discussion of the Redevelopment Assistance Capital Program—Construction of the Lancaster Library

The Board held discussion with Ms. Campbell with the City and members of the Commonwealth of Pennsylvania, Office of the Budget regarding the Redevelopment Assistance Capital Program (RACP) Project Number 2690-00 for the construction of the Lancaster Public Library. It was agreed that further discussion on the topic would be held in executive session as a matter of real estate.

A motion was made by Mr. Sollenberger, seconded by Mr. Weaver to recess into executive session. The Board went into executive session at 8:16am.

At 9:00am, the Board resumed its public meeting. A motion to table items four and five on the Agenda was made by Mr. Weaver and seconded by Mr. Sollenberger. All Board members present approved the motion to table items four and five on the Agenda, which included 4. Approval for Partial Use of 151 North Queen Street Property as Land Match for RACP Project Number 2690-00, Construction of the Lancaster Public Library; and 5. Approval for Request to Reserve Unused Portion of Current Appraised Value and Additional Future Appraised Value to Be Used for Any Future Parking Authority RACP Projects.

## **Finance**

Mr. Radecic presented the July 2024 Board financials including the financial highlights, financial statements, balance sheet, and the final Christian Street Garage Project cost summary showing the project, upon completion, to be under the revised budget by approximately \$358,000.

Mr. Radecic announced that in approximately 45 days official notice will be sent to LPA customers explaining changes in the parking management platform and Authority billing policies.

# **Economic Development**

Mr. Cohen shared that an official lighting ceremony was held on August 16, 2024 for the Christian Street Garage New Lancaster Rainbow façade in Ewell Plaza. The City's Mayor and Mr. Cohen shared a few words marking the occasion and celebrating the final completion of the Christian Street Garage project.

Mr. Cohen provided an update on the design phase for the North Prince Street office renovation with Morotta Main Architects in Lancaster, PA.

A motion was made by Mr. Sollenberger and seconded by Mr. Weaver to adjourn the meeting. All Board members present approved the motion. At 9:12AM, the meeting adjourned.
